ELIGIBILITY CRITERIA

- ❖ New equipment must be purchased, installed, and operating (generating kWhs) in 2022 on Jackson Electric Cooperative's lines. Active membership only.
 - ❖ Rebates are in place through December 31, 2022, or until funds are depleted. **Availability of rebates and incentives is subject to change without notice.**
 - ❖ Rebate not to exceed the equipment cost.
 - ❖ Additional eligibility criteria may apply. Contact Jackson Electric Cooperative for details.
 - ❖ Submit the required documentation listed below no later than **60 days of invoice date**. If submitted after December 31, 2022, equipment will be considered for the 2023 incentive if offered. Members are encouraged to submit as soon as possible to ensure rebate.
 - ✓ Completed rebate form;
 - ✓ A copy of your receipt or invoice for each item purchased with the purchase price and date of purchase highlighted; and
 - ✓ Documentation showing the equipment has been installed
 - ❖ Rebate amounts less than \$250 will be applied as a credit to your billing statement.
